This conveyance is made subject to all applicable covenants, easements and restrictions of record and to the lien of 2016 *ad valorem* taxes which are not yet due and payable.

The property conveyed herein conveyed does not include the primary residence of the Grantor.

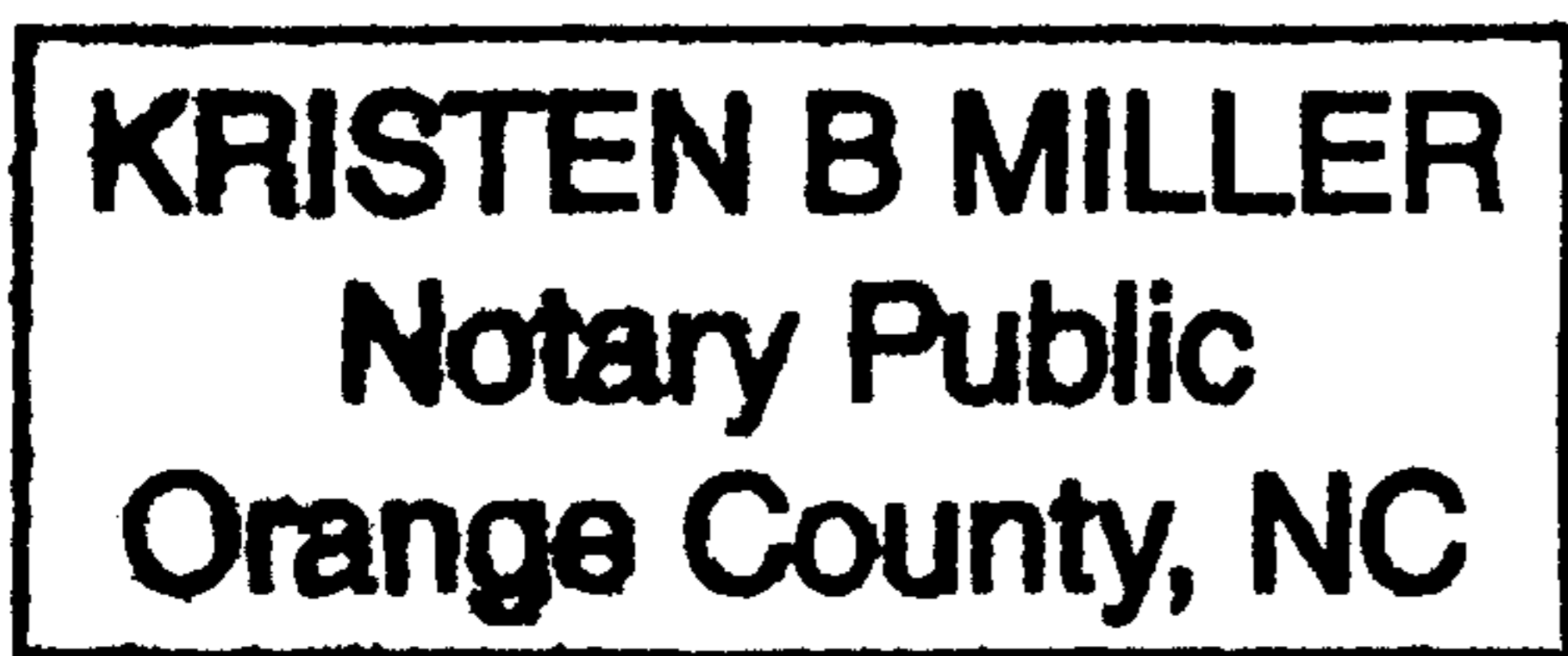
