

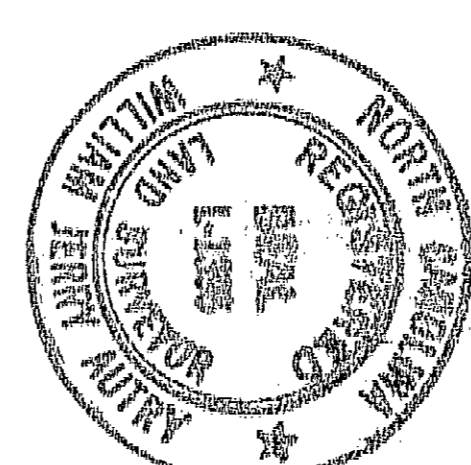
I, William Jerry Autry, R. L. S. #1395, certify the following is correct:

The information available to me is such that I am unable to determine the provisions in the preceding statements.

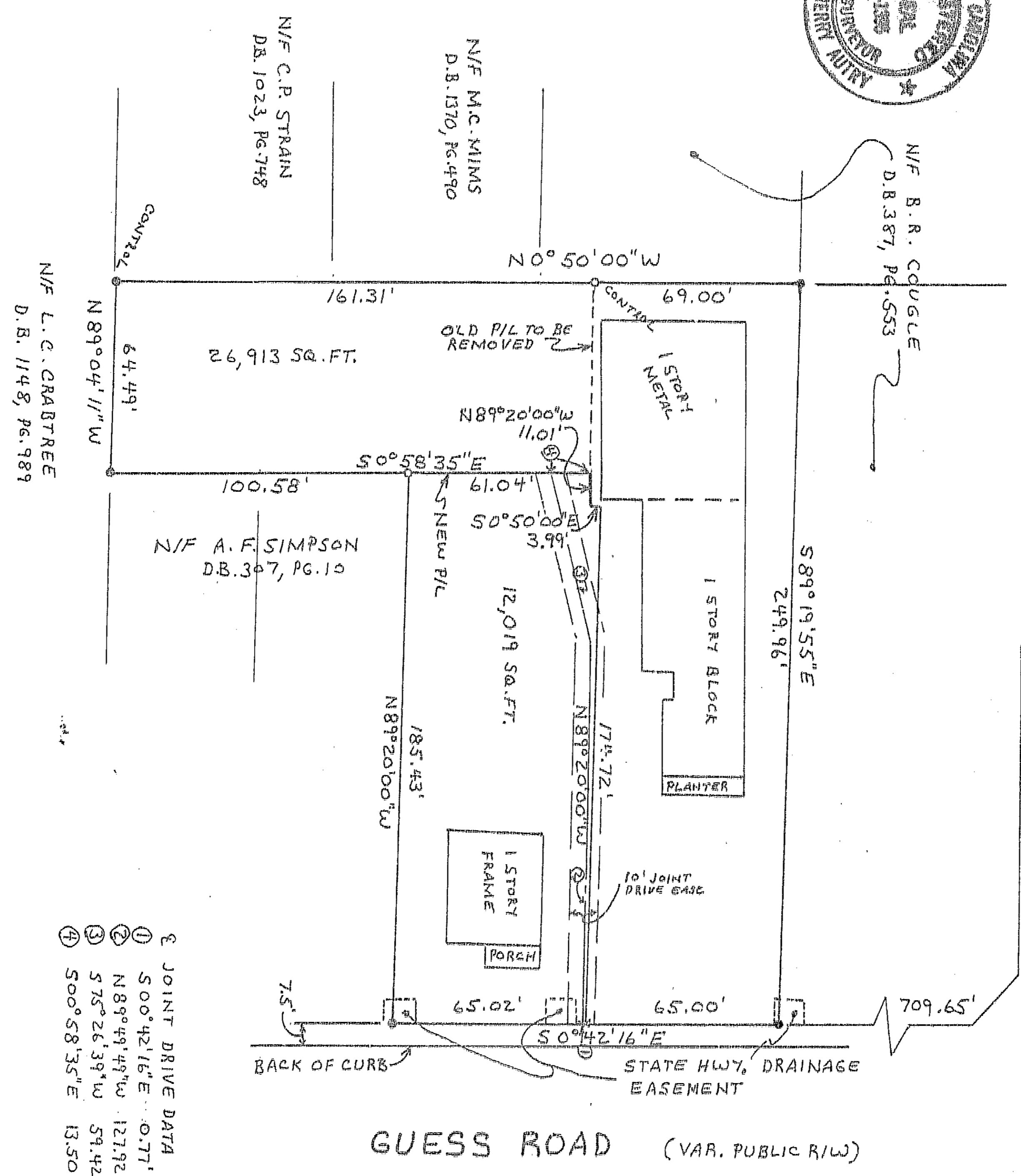
